Dual Enrollment - In-State Students

Thank you for contacting us for information about our Dual Enrollment Program here at Bryan College. Please use the links below to answer some of the common questions. Our DE Program is for high school junior and seniors who have a minimum of a 3.0 GPA. You may apply during your sophomore year, but you will not be allowed to register for courses except for your junior/senior years. You can register and take 6 credits/summer term and 12 credits/fall and spring term. You can also take our courses the summer after your sophomore/junior/senior year graduation at the current DE rate, as long as you haven't attended another college during that time.

We offer **online** and **onsite** courses for qualified high school students.

- Bryan College is **regionally accredited** (SACS), so credits transfer.
- Fall, spring, and summer instruction--with a distinctive Christian worldview.
- Courses are \$160 per credit hour + \$20 non-refundable course fee or potentially free if you qualify for the Tennessee Dual Enrollment Grant (See below).
- Online students see courses from our <u>schedule of course offerings</u> (*these courses are a general overview of what is typically offered. Please check back each term to verify if other courses have been added/dropped) http://www.bryan.edu/online/courses
- On-campus at Bryan College students can see course offering course list.
- Online offers flexible scheduling (no live-streaming). See course sample.
- Academic support includes free <u>tutoring</u>.

Tennessee Dual Enrollment Grant:

- Students must be eligible and apply for the grant each semester that tuition is payable and due.
- Continued eligibility is based upon maintaining a 2.75 grade point average on all college courses (not high school courses) taken in the dual enrollment in any and all colleges. This is the requirement for the state of Tennessee. Bryan College DE courses require you to maintain a 3.0 grade point average to use the TN grant for our courses.
- Students may request up to 2 grant allotments within a semester.
- If you opt for a second grant allotment, you must contact Beth Hixson in financial aid (hixsonbe@bryan.edu or 423-775-7557) with your full name, school, and request.
- If you plan to register for courses at 2 separate colleges, you must contact Beth Hixson in financial aid (hixsonbe@bryan.edu or 423-775-7557) and complete the <u>consortium agreement</u> at http://www.bryan.edu/financial-aid/de.

- After you have used all of your TN DE Grant, Bryan College offers a \$200 scholarship per course starting with the 4th course.

Summer I Term: May 14, 2019 – June 24, 2019

- Application deadline: April 27th, 2019
- Course registration: March 26th, 2019 April 30th, 2019 (any registrations after this date will require payment first before being allowed to register. If using the DEG, you will pay first then wait for DEG to reimburse you.)
- Tuition due or grant application submitted by April 30th, 2019. Students may be dropped from course if tuition has not been paid by deadline.
- Cost \$160 per credit hour for DE students + \$20 non-refundable course fee -
 - \$500 for 3-cr course, \$660 for 4-cr course
- Non-Degree students \$365 per credit hour

Summer II Term: June 25, 2019 – August 5, 2019

- Application deadline: June 1st, 2019
- Course registration: March 26th, 2019 June 12th, 2019 (any registrations after this date will require payment first before being allowed to register. If using the DEG, you will pay first then wait for DEG to reimburse you.)
- Tuition due by June 11th, 2019. Students may be dropped from course if tuition has not been paid by deadline.
- Cost \$160 per credit hour for DE students + \$20 non-refundable course fee -
 - \$500 for 3-cr course, \$660 for 4-cr course

Non-Degree students - \$365 per credit hour

Fall 2019: August 19, 2019 - December 12, 2019

- Application deadline: August 1st, 2019
- Course registration: July 1st, 2019 August 14th, 2019 (any registrations after the tuition deadline will require payment first before being allowed to register. If using the DEG, you will pay first then wait for DEG to reimburse you.)
- Tuition due or grant application submitted by August 1st, 2019. Students may be dropped from course if tuition has not been paid by deadline.
- Cost \$160 per credit hour for DE students + \$20 non-refundable course fee -
 - \$500 for 3-cr course, \$660 for 4-cr course
- Non-Degree students \$365 per credit hour

Spring 2020: January 13, 2020 - May 20, 2020

- Application deadline: December 1st, 2019
- Course registration: October 14, 2019 December 15, 2019 (any registrations after the tuition deadline will require payment first before being allowed to register. If using the DEG, you will pay first then wait for DEG to reimburse you.)
- Tuition due or grant application submitted by December 1st, 2019. Students may be dropped from course if tuition has not been paid by deadline.
- Cost \$160 per credit hour for DE students + \$20 non-refundable course fee -
 - \$500 for 3-cr course, \$660 for 4-cr course
- Non-Degree students \$365 per credit hour

Please ensure that when you apply, to use a personal email that belongs to the student. This email must be unique in our system. That becomes a permanent email address for them in our system.
